INNOVATION

Individuals who display unique, forward-thinking approaches towards environmental issues and concerns. They take on a rather fearless approach to advance beyond the status quo of environmental affairs, and change in ways to better push for sustainability and change.

COMMITMENT

Individuals who exhibit true dedication and enthusiasm to environmental change, sustainability, and the implementation of green business practices.

COLLABORATION

Individuals who work with others both inside and outside of the environmental sphere to both produce and promote positive results in environmental change.

EDUCATION

Individuals who understand that knowledge is power, on all levels. They strive to promote the education of environmental sciences and issues on all levels, from in-school education to community guidance efforts, that encourage a transfer of knowledge to promote environmental sustainability on a grand scale.
